



Colorado River Women's Council (CRWC) 2009 Colorado River Leadership Program's Community Class Project "Operation Desert Stage" (ODS)

Car/Cash Raffle Rules

The Colorado River Women's Council (CRWC) is a non-profit designated entity under the laws of the State of Arizona whose primary purpose is to generate funds to support women and children and other fund raising activities for the community in Bullhead City, Arizona.

1. ELIGIBILITY. Each entrant, by entering the Raffle, agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state and federal laws and regulations, and further agrees to release the organization and its directors, officers, agents and employees from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. The Raffle is open to any eligible person residing in a country or state where the Raffle is not prohibited. Entrants must be 21 years of age or older.

2. TICKET PURCHASE. The cost to purchase a single entry ticket for the Raffle is \$50.00 (U.S. Funds only) and is not tax deductible. Any entrant may purchase more than one ticket. Tickets will be sold through the Colorado River Women's Council members and auxiliary members. An entrant can also enter the Raffle by purchasing a ticket over the Internet from our secure website at, www.operationdesertstage.com. All on-line ticket purchases can be made by VISA, MasterCard, or Discover Card and will be charged using the secure PayPal credit card processor. Any dishonored credit card will be considered an invalid entry, and CRWC will endeavor to notify the entrant by mail. All on-line ticket purchases must be received by 5:00 p.m. on August 12, 2010. The remaining tickets will be available (cash only) up to 2:00 p.m. on August 14, 2010. Any payments received after closure of the Raffle will be returned to the entrant. Upon receipt of a completed entry and valid payment, the ticket will be issued. The receipt shall be mailed to the entrant within ten (10) business days of issuance.

3. PRIZE.

GRAND PRIZE. The Grand Prize is the Grand Prize winner's choice of a 2011 Chevrolet Camaro RS SS 6.1L V8 OR a \$30,000.00 cash prize. The 2011 Chevrolet Camaro includes standard features only as designated by Chevrolet. Options may be added at winner's sole expense. Pricing for options will be provided by the dealership, which is identified by CRWC. The winner must negotiate directly with the dealership for any and all options desired. CRWC

will not act as agent on behalf of the winner or the dealer/dealership in ordering the vehicle with options.

If the vehicle prize option is chosen, the Grand Prize winner must take delivery of the vehicle at a dealership designated by CRWC. The winner, at his or her sole expense, may choose to have the vehicle shipped to another location for final delivery. The winner is responsible for making any and all such arrangements and any fees associated. CRWC will not act as agent on behalf of the winner or dealer/dealership in arranging final transportation. Timing of the delivery of the vehicle is at the discretion of designated dealership. This model may be in high demand, delivery may take time.

The prize winner shall be responsible for all costs associated with title, registration, licensing, delivery and other applicable fees associated with their respective prizes, as well as for all local, state and federal taxes, including, but not limited to without limitation, all luxury, special and income taxes that may be applicable. The winner will be required to provide CRWC with a valid social security number and must complete all IRS and similar forms requested by CRWC prior to delivery of their prize. Failure to do so within thirty (30) days of request shall result in an automatic forfeiture of such winner's prize, and the prize will be treated as a donation to the CRWC – 2009 Colorado River Leadership Class without compensation to the winner.

4. WINNING CHANCES. A maximum of 2,500 tickets will be sold. Each ticket represents one chance to win. You may enter as many times as you like. Chances of winning depend on the number of eligible tickets sold. If 2,500 tickets are sold, the odds of winning the Grand Prize are 1:2,500.

5. DRAWING. The winner will be determined by a random drawing of all the eligible tickets received by the entry deadline. The Grand Prize Drawing will be held on Saturday, August 14, 2010 at 3:00 p.m., at the Post Regatta Party held at Rotary Park in Bullhead City, AZ. The winner need not be present to win.

6. MODIFICATION OR CANCELLATION OF DRAWING. CRWC reserves the right to cancel or modify the Raffle. If 1,500 tickets are not sold by 5:00 p.m. on Wednesday, August 12, 2010, CRWC, at its option, may modify the Raffle by withdrawing the Grand Prize and split the remaining net proceeds (income less expenses) equally between the Grand Prize winner and CRWC. If all available tickets are sold before the scheduled Grand Prize drawing date (i.e., CRWC has determined that the raffle is "sold out"), CRWC reserves the right to end the raffle early, thus putting the winnings in the hands of winners sooner. As with the regularly scheduled Grand Prize Drawing, it will be announced through local media sources.

7. WINNER. Winner need not be present to win. The winner will be notified by phone, e-mail or by mail based on the information received on the ticket stub. The name of the winner will be available to all media and will be available and listed on the CRWC/ODS website. The winner shall agree to allow CRWC to use their name, likeness, and any statements made by them regarding the prize for advertising or publicity purposes without compensation. Winner may be required to complete and return an affidavit of eligibility and liability release. Failure to do so if requested or if one otherwise fails to comply by these rules and/or to make arrangements to claim his or her prize within thirty (30) days of notification, the entry will be void and the entry will be treated as a donation to the CRWC-2009 Colorado River Leadership Class project.

8. AWARDING OF PRIZE. More than one name may be listed on an entry form, but the first name listed shall be deemed to be the entrant. Winner will be required to provide an acceptable identification to establish identity. A social security number must be provided, and it must be

that of the entrant. Delivery or payment of any prize shall be made solely to the entrant. It is the sole responsibility of the entrant in a multiple party entry to allocate any such prize among the participants in a multiple party entry.

9. AUTHORITY AND CONTROL. The decision of CRWC shall be final in all matters concerning the Raffle. The Raffle is subject to the laws of the State of Arizona. Void where prohibited by law.

10. VEHICLE. Model 2011 Chevrolet Camaro RS SS 6.1L V8 with standard options only, as noted in Section 3. A "Camaro" is a registered trademark of Chevrolet.
